Helpful hints on age groups

Children should be in age groups based on their age at the start of the cohort, when they're identified as newly enrolled in January, February, or March of 2020. For example, if a child is four years old when they're newly enrolled, they should continue to be reported in the "ages 1-5" group at 6 months, 12 months, and 18 months later.

The oldest children in the cohort must be no older than 16 years (and 0 months) to ensure they don't age out of the program at the end of the 18-month tracking period. That means children in the "ages 13-16" group who are newly enrolled in January 2020 must be born after January 2004. Similarly, children who are newly enrolled in February 2020 must be born after February 2004, and children newly enrolled in March 2020 must be born after March 2004.



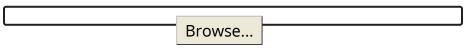

The evaluation found that 46% of participants completed the entire program and 70% completed at least one module. The most common reason for incompletion was lost contact/family moved from area. It is suspected that now that the program is statewide this reason for attrition will decrease as the family can pick up services in their new area. The most completed module was the Health Module. Participants increased their health knowledge by an average of 43% over baseline going from a combined average of 54% to 97% on topics such as doctor's appointments, care at home, and emergency. Participants who completed the parent/child interaction module increased their knowledge an average of 51% over baseline going from a combine average of 49% to 99% on daily activity and play activity. Participants reduced the total number of safety hazards in their home by 85% from before the hazard module to after the module.

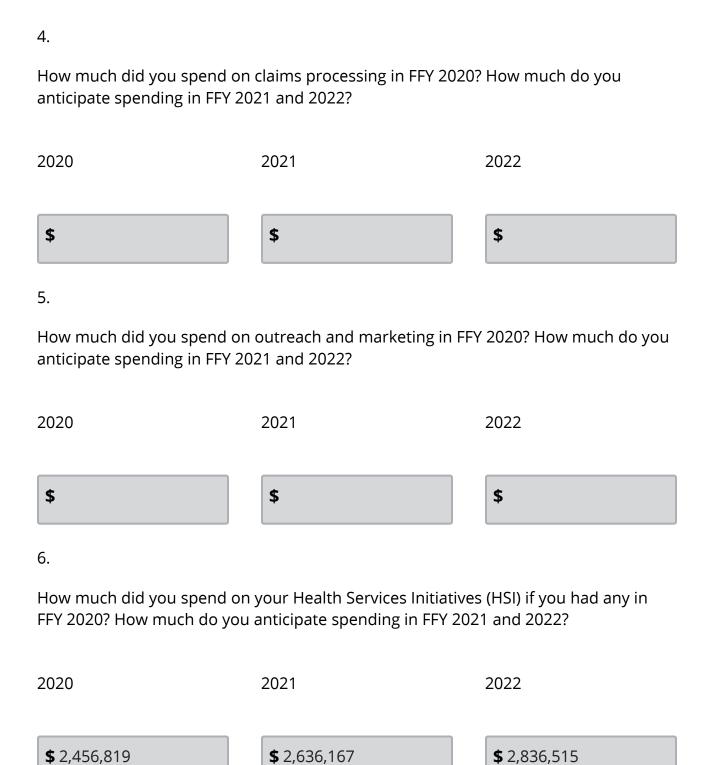
