




October 2022 Medicaid and CHIP Enrollment Trends Snapshot



Center for Medicaid and CHIP Services

Enrollment Snapshot

- To be responsive to questions on Medicaid and CHIP enrollment, particularly given the impact of the COVID-19 public health emergency (PHE), this Enrollment Snapshot captures high level information on the most recently submitted month of Performance Indicator Enrollment Data¹ within the context of trends since February 2020², focusing on:
 - Total Medicaid and CHIP enrollment;
 - Medicaid enrollment;
 - CHIP enrollment;
 - Adult enrollment; and
 - Child enrollment.
- This analysis also captures high level information on the trend in the number of Medicaid and CHIP applications received by states.

¹ Performance Indicator Enrollment Data counts individuals receiving full-scope and comprehensive Medicaid and CHIP benefits.

² February 2020 serves as a baseline prior to the impacts of the COVID-19 pandemic and the enactment of the Families First Coronavirus Response Act (FFCRA) in March 2020. Section 6008 of FFCRA includes a continuous enrollment condition, which makes available a temporary increase to each state or territory's federal medical assistance percentage (FMAP). As a condition of receiving the FMAP increase, states must meet several requirements pertaining to eligibility and maintenance of enrollment.

Key Findings

- In October 2022, 91,342,256 individuals were enrolled in Medicaid and CHIP.1
 - **84,374,871** individuals were enrolled in Medicaid in October 2022, an increase of 527,714 individuals from September 2022.
 - 6,967,385 individuals were enrolled in CHIP in October 2022, a decrease of 65,392 individuals from September 2022.²
- Since February 2020, enrollment in Medicaid and CHIP has increased by 20,782,688 individuals (29.5%).
 - Medicaid enrollment has increased by **20,546,153** individuals (32.2%).
 - CHIP enrollment has increased by **236,535** individuals (3.5%).
- The Medicaid enrollment increases are likely driven by COVID-19 and the continuous enrollment condition in the Families First Coronavirus Response Act (FFCRA).³

²The decrease in CHIP enrollment is primarily driven by an update in reporting methodology by the state of Texas. In Texas, CHIP enrollment decreased by 14.3 percent (66,563 individuals) while Child Medicaid enrollment increased by 2.2 percent (83,069 individuals) in October 2022.


Key Findings (continued)

- In October 2022, 2,469,207 applications for Medicaid and CHIP were submitted directly to states.¹
 - The number of applications submitted directly to states was 1 percent lower in October 2022 compared to September 2022.
- In October 2022, 125,893 applications were transferred from the Federally Facilitated Marketplace (FFM) to states.²
 - The number of transferred applications was 5 percent higher in October 2022 compared to September 2022.




Nationally, total Medicaid and CHIP Percentage change in Medicaid and CHIP enrollment enrollment increased by 0.5 percent from September 2022 to October 2022. In 16 Number Connecticut, Maine, and Missouri, total of states Medicaid and CHIP enrollment increased by 3 1.0 to 3.0 percent.(1) In 29 states and the District of Columbia, total Medicaid and CHIP -0.5% +0.0% +0.5% +1.0% enrollment increased by 0.5 to 1.0 percent. Total Medicaid and CHIP enrollment ND MT increased by less than 0.5 percent in 16 states. 

Data Context: (1) In Connecticut, total Medicaid and CHIP enrollment increased by 1.6 percent (15,714 individuals). In Missouri, total Medicaid and CHIP enrollment increased by 1.5 percent (20,316 individuals). In Maine, Medicaid and CHIP enrollment increased by 1.0 percent (3,610 individuals). The state's child Medicaid enrollment increased by 7.7 percent (9,216 individuals) while CHIP enrollment decreased by 62.1 percent (8,462 individuals). As of December 23, 2022, Maine is investigating their CHIP enrollment decreases.

(2) In New Mexico, total Medicaid and CHIP enrollment decreased by 0.1 percent (1,064 individuals). In Montana, total Medicaid and CHIP enrollment decreased by 0.3 percent (1,033 individuals). As of December 23, 2022, both states are investigating their enrollment decreases.



Kansas is excluded because the state did not report applications data for September 2022 and October 2022. **Data Context:** (1) In Georgia, total applications increased by 81.0 percent (29,266 applications). The state attributes this increase to the October 1, 2022 implementation of Express Lane Eligibility, as well as an influx of applications related to a one-time cash assistance payment that required applicants be eligible for Medicaid. In Maine, total applications increased by 94.0 percent (5,634 applications). The state attributes this increase to the state receiving several thousand Marketplace applications in October.

Background

- This is a Center for Medicaid & CHIP Services (CMCS) Medicaid and CHIP Coverage Learning
 Collaborative (MAC LC) project that monitors Medicaid and Children's Health Insurance Program (CHIP)
 enrollment trends, primarily using the Centers for Medicare and Medicaid Services (CMS) Performance
 Indicator Data.
- The MAC LC is a CMCS project that provides a forum for facilitated discussion and learning across CMS and states, with the goal of implementing and improving the programs, tools, and systems needed to ensure high-performing state health insurance programs. The MAC LC has enabled CMS to more effectively identify issues and also monitor and improve program performance.
- This snapshot is a companion to the October 2022 Medicaid & CHIP Application, Eligibility, and Enrollment Data posted on <u>Medicaid.gov</u>.
- The Enrollment Trends project primarily relies on Performance Indicator Data. All states—including the District of Columbia—provide data each month about their Medicaid and CHIP eligibility and enrollment activity. These data reflect a range of indicators related to key application, eligibility, and enrollment processes within the state Medicaid and CHIP agency.
