Stephanie Coppel: It looks like we've got a fair amount of folks on the call, so we can get started with our Qmr

Stephanie Coppel: system. Demo, i'm. Stephanie Cole. I am the Cms. Lead on the new Qmr system. Build, and we are so excited to be sharing it with you today and appreciate your time to

Stephanie Coppel: give a little demo of what what you'll be using.

Stephanie Coppel: This uh will just be a demo of the application itself, walking through the main features and functionalities of the site. Uh, this exact demo will be repeated next week on Tuesday the thirteenth. Uh, if you are attending today, you do not need to attend this session on Tuesday it will be a

Stephanie Coppel: of what we are doing here. Um. In addition, on the fifteenth next Thursday there will be a training on the policy portion of the site. And today we'll just be reviewing the technology. Ah,

Stephanie Coppel: piece of Qmr.

Stephanie Coppel: Um

Stephanie Coppel: As we go through. Please add any questions to the Q. And a box below um, and after the site, Demo, we will go through and answer as many as we have time.

Stephanie Coppel: Um before we jump into the demo. I wanted to make a quick announcement. You all should be receiving an email

Stephanie Coppel: with the same information later today. Um, But there are some issues with the math quality. Ta, mailbox. Um, the email address where you would typically send any policy related questions.

Stephanie Coppel: Um due to a an agency-wide um email transition at Cms. So for now, um, if you are sending a policy related question to that mailbox, please be sure you copy the Mvct help mailbox as well. Um, until you know that the T email box is

Stephanie Coppel: working again.

Stephanie Coppel: Now that we have all that housekeeping out of the way, we can start talking about the new Qmr site.

Stephanie Coppel: Um

Stephanie Coppel: before I share my screen and show you the site hopefully. Most if not all, of you, have. Ah requested a role in Idm to gain access to the site. If you have not. Um. Some emails have been sent out with instructions or you can email the Mdct. Helped us

Stephanie Coppel: to get instructions on how to gain

Stephanie Coppel: um Something different on this site than you may have been accustomed to in their previous version of quality measures

Stephanie Coppel: that all State users have one role. There's no approval role, There's no hierarchy. This was done to allow the States to operate in whatever fashion makes sense

Stephanie Coppel: within your state, so you all can coordinate amongst yourselves how you want to conduct the review and approval process just within your State before submission, and this allows everyone the most flexibility to do that.

Stephanie Coppel: Um. So with that i'm going to go ahead and share my screen. Just a quick warning that. Um, i'll be demoing to you today from a test environment. There are a couple things that you'll see that will not appear

Stephanie Coppel: in the site um that you can log into, and i'll highlight those um, but just a few extra things that we added in our testing site to support all the testing we did to make sure that this site is perfect for you all to start using Zoom.

Stephanie Coppel: So without further ado,

Stephanie Coppel: here is the home screen of the new Mdct. Qmr.

Stephanie Coppel: Site. Um. You'll note that the safe automatically lands on fy twenty one in the upper right hand corner. It'll orient you to the year you're in um,

Stephanie Coppel: because we are reporting in for fy twenty, one and fy twenty two In this reporting period you'll see you can toggle between them. Um by selecting a new year

Stephanie Coppel: and then going back. So just make sure you're aware of what year you're in as you are entering data.

Stephanie Coppel: Um,

Stephanie Coppel: this home screen. Ah is where you'll start to navigate into each of your core sets to start completing your measures

Stephanie Coppel: upon first login. You'll note that

Stephanie Coppel: the adult corset measures

Stephanie Coppel: already exist. Um, since the majority of States all reported the exact same way. Um, Right now the status is complete because I set it up to show you something a bit later, but normally it will say, not started. You'll see that it indicates the type, of course, that adult right here, and then the status again will change. You can take some actions over here these three dots.

Stephanie Coppel: Um, that allows you to export this complete all measures and reset all measures is one of those testing things that exists in what I'm showing you, but not in the site that you'll be using

Stephanie Coppel: um.

Stephanie Coppel: So i'm gonna go ahead and add some core sets here so we can start doing some of our reporting. Um! You'll see some tiles at the bottom that will help you take the next step to add a child's courses.

Stephanie Coppel: Ah! When we navigate into here, it will ask us how we're recording our child, or set whether we're recording in separate core sets for medicaid and chip, or in a combined core set.

Stephanie Coppel: So i'm going to go ahead and select, combined and click, create

Stephanie Coppel: um, and then it'll take us back to our home screen, and our child course set is available for us to start working on, but maybe you selected that, and it came up, and you realized, Oh, no, I meant to select that we are recording separately.

Stephanie Coppel: You can go ahead and navigate over here and click delete um. We want to make sure that this doesn't happen accidentally, and you don't

Stephanie Coppel: um lose any data by accidentally deleting something. So we have this handy pop-

up that forces you to type in the word delete to confirm. This is what you are choosing to do um once you delete a corset um that data is gone, and you will have to re-ent it

Stephanie Coppel: for awareness. So we'll go ahead and delete that core set.

Stephanie Coppel: Ah, you'll see now that we can go back and have a job, of course, that I realize that I want to report separately. So i'm going to make that selection of here and create.

Stephanie Coppel: Ah! And you'll see here that it created two separate core sets for child. Um. You'll also notice that at the bottom it won't. Let you add another child for set, because you've already created your child, for since Um, so there's no need to add an additional one.

Stephanie Coppel: Um for

Stephanie Coppel: health home. If your state has a health Home Porset, for any fiscal year can go to that tile um and follow a similar pattern.

Stephanie Coppel: There will be a drop down that shows all of the spas that

Stephanie Coppel: you need to report on for this fiscal year, so i'll go ahead and select the one

Stephanie Coppel: that is available to me, and i'll click, create.

Stephanie Coppel: We'll get back to the home screen, and you'll see that we have our health and corset right here.

Stephanie Coppel: You can see the type of each has changed. Um, and the status is different, and i'll explain why. Um. These new trial core sets show in progress and health phone shows not started, but you can also see from this home screen how many uh, how many actual measures are completed. Just at a lamb. Right? You can see that we Haven't even started helpful. Um! But that we've filled out all the adults, all the adult measures.

Stephanie Coppel: Um, which is really handy. Um, and you'll also note down here. Once we um created our health home corset. It won't. Let us add another one, so it really helps you navigate exactly what you need, and nothing that you don't

Stephanie Coppel: so we'll go into the child. Porset Page.

Stephanie Coppel: You'll see on this screen that it lists all of the Child Coorset measures

Stephanie Coppel: um, and you can go through there. Um! On the top. This blue bar. This site is going to grant you where you are, so you know at a glance that you are in a child, of course. Set the medicaid for set and not the chip

Stephanie Coppel: um, and you'll see that all of these measures have the status of not started. It has today's date, and this time, because I just created this child poor set. Um! We'll go down to these that are already marked complete

Stephanie Coppel: um and click into those. So the ones that are ah automatically marked Complete are instances where Cms. Has received this data from alternate sources. Um! So there's nothing for you to do here. There's no action to be taken on your part, but just shows you that. Um, This is information Cms needs, but we're getting it elsewhere.

Stephanie Coppel: Um, we don't need anything from you at this time,

Stephanie Coppel: so we can

Stephanie Coppel: go back.

Stephanie Coppel: We're back in our child for Set. You can see at the top that

Stephanie Coppel: there is a handy little chart to show the total measures completed. So we have a bit of a ways to go to complete this courseet

Stephanie Coppel: um,

Stephanie Coppel: and we can jump in

Stephanie Coppel: to an actual measure.

Stephanie Coppel: Um. So first thing you'll notice when we land here we have our nice blue bar that's going to orient us. Um! You can see that we're in fiscal year twenty, twenty, one, and then the measure that we are in

Stephanie Coppel: this blue bar will follow us as we scroll down the screen. So at any given time you can click, save

Stephanie Coppel: and it'll save and have this screen pop up down at the bottom that it was successfully saved. So, as you're working, I know these forms get very long. Um! That you can click save It's always available to you.

Stephanie Coppel: Um. In addition, you can print from here, and i'll just show you how that works when you click the print button and then a load of preview and allow you to save it as a Pdf

Stephanie Coppel: for the individual measure, and i'll show how we can print an entire courseet, a little leaker

Stephanie Coppel: um

Stephanie Coppel: something

Stephanie Coppel: else that is different in this new system. And the way that Cms is collecting

Stephanie Coppel: quality-measured data is that We are asking that each State

Stephanie Coppel: complete each measure, even if it means telling us that we are not reporting on this measure. So the first question in every single measure is, Are you reporting on this measure. Yes or no. Um, if you click Yes, you'll navigate through the form um and fill it out

Stephanie Coppel: and submit data to Cms. If you select. No, you're not reporting on this measure. Cms is asking states to tell us why. Um, So we can better understand why a State might not be reporting on a specific measure. Is the service not covered? Is the data not available, or there limitation? Um, and selecting

Stephanie Coppel: of those you can go down and complete measure.

Stephanie Coppel: But we do ask that each State complete each and every measure, even if you are choosing not to submit data to Cms. Um, which would include telling us why.

Stephanie Coppel: Um, as we navigate through, just note that with these radio buttons that appear here Um! That using the arrows on your keyboard will change the selection rather than um kind of tab through the questions. So just be careful using your keyboard to navigate and know that you may be changing an answer um unknowingly.

Stephanie Coppel: So we suggest that you use your mouse to kind of click through and make selections.

Stephanie Coppel: Um! As we go through the form. I want to show you some different Ah! Examples of types of validation. We have, as you know, there are a ton of back and validations. Um, for these measures. Um! And I want to show you how different

Stephanie Coppel: validations operate, and how you'll be alerted as you are going through and filling out the form. Um. The first really important piece to keep in mind is that this form is created

Stephanie Coppel: with the idea that the user will start and fill out the form in order. Um, as you know, with those validations some parts later in the form um

Stephanie Coppel: rely on information provided at the beginning of the form. So if you fill it out out of order. Ah! You won't, receive the correct validations, and could potentially be submitting Ah, incorrect data. So we suggest that you start at the top and fill it out in order from top to bottom.

Stephanie Coppel: So i'm going to go ahead and make some selections here.

Stephanie Coppel: Um!

Stephanie Coppel: So um to give an example of validations for date range, for example. Um, I am going to say that the start date

Stephanie Coppel: is nine, twenty, twenty one. You can either take this in on your keyboard or use Ah, this picker here. Um! But if I start typing an end date

Stephanie Coppel: that occurs before the start. Date um which wouldn't make sense. You will see in a moment a pop-up come up on the bottom of the screen, telling me that

Stephanie Coppel: um

Stephanie Coppel: the start date must be before the end date, and it will clear that data that is incorrect and allow me to enter something new. So

Stephanie Coppel: when I fix that

Stephanie Coppel: no validation. So one place you'll see. Validations are in the center bottom of the screen. You'll also see that, for save

Stephanie Coppel: successfully saved,

Stephanie Coppel: I'm going to go through and just make some more selections

Stephanie Coppel: get down to the ndr sense.

Stephanie Coppel: So this is a really good example of needing to fill out questions at the top,

Stephanie Coppel: so that um

Stephanie Coppel: questions at the bottom are working properly. So we selected above

Stephanie Coppel: administrative data source only. So with that

Stephanie Coppel: the rate for the ndr set will auto-calculate, and the user cannot override it. So i'm going to go ahead

Stephanie Coppel: and type in and you can't see me typing, but I am trying to type over this, and it's not letting me um. The rate is auto-calculated and cannot be

Stephanie Coppel: over. So if I go up here, and I add administrative data plus an alternate data source and go back down. This will now allow me to override this rate, and I know that the Ta team will talk

Stephanie Coppel: more about these rules in their policy training late next week, but just want to show you a little bit about how this functions.

Stephanie Coppel: Um,

Stephanie Coppel: So we can go

Stephanie Coppel: down more questions. Um. Something else to note is that these text boxes, these large text boxes have these little tiny lines in the bottom right hand corner. If you hover over them, you can expand this text box. Um. So

Stephanie Coppel: in case you have a lot to right here, you can expand it to make room for everything that you need to say. We also have the opportunity for States to add attachments down here. You can drag a drop or browse and upload manually from your computer, and then we get to the end.

Stephanie Coppel: Ah, first I want to highlight this clear data button, this red button. You will not see this when you log into the site. This is something that we use for testing,

Stephanie Coppel: since we do so much testing and entering data, it's a quick way for us to clear it and and test a different way. So you will not see that what you will see is this validate measure?

Stephanie Coppel: Um! You saw the validation with the date range, where it appeared. Um! As I was typing something that was incorrect and alerting me in line. Um! In the moment I was doing it.

Stephanie Coppel: This validate measure is a manual validation. So it's going to take into account a ton of things throughout the form um that it needs to run manually because it's taking into account different selections from different questions. Um, So i'm going to go ahead and click, validate measure.

Stephanie Coppel: and it's telling me success. The measure has been validated successfully. That is great.

Stephanie Coppel: I'm going to go ahead and delete something so you can see

Stephanie Coppel: validation

Stephanie Coppel: er so we can click, validate measure again, and I get this error

Stephanie Coppel: that the date range must be completed.

Stephanie Coppel: Also a note. If you saw the pop up on the bottom center of the screen. That was each click of validate measure or complete measure the measures automatically.

Stephanie Coppel: So you can see here I have this error, so I can go back up to the date range.

Stephanie Coppel: Fill it out

Stephanie Coppel: now. They gave back down to the bottom and validate again,

Stephanie Coppel: and see that it cleared the measure. I'm sure many of you are probably wondering Why didn't I get an error for not filling out all of the questions? There are many blank questions,

Stephanie Coppel: something else different in this site is that there are no hard stops. Um! So we are giving you validation warnings. We're giving you errors to show you where you may need to take a second look at your data, But, um, we do not want to block

Stephanie Coppel: any of you from submitting things to Cms, even if they are incomplete. Um. So you'll see that I did not fill out part of this measure, and i'm going to hit the complete measure, and it's going to allow me

Stephanie Coppel: mark this measure complete, even though I didn't fill it out completely. I want to

Stephanie Coppel: show an error. I wanted to throw up an error. Just so. I can show you what happens if you try and submit

Stephanie Coppel: if you try and complete a measure when there is

Stephanie Coppel: issue on the form. So if I go to complete measure,

Stephanie Coppel: it's warning me. Hey, there's still errors on this measure. Would you like to complete, or you sure you want to see um, and I i'm going to select. Yes, that I know there's an issue, but I want to submit it. Anyway, this is the best I could do. Perhaps it's the most information I have. Um, so i'm gonna point. Yes,

Stephanie Coppel: and it's going to allow me to complete and we'll take you back to the measure list, and you'll see we were working in A and B Ch. Um. We marked it as yes, we're reporting in fiscal year two thousand and twenty one, and we marked it complete at one point.

Stephanie Coppel: Um! Another piece of that no hard stops is that if you want to go back in after clicking complete. You can edit this

Stephanie Coppel: um. So if Cms comes back with um some requests for changes as they're reviewing it, or potentially, you get more information after you put complete um, you can go ahead and make those changes and click complete

Stephanie Coppel: again. Um!

Stephanie Coppel: So again i'll get that same validation here. I would still like to complete.

Stephanie Coppel: You see that it's updated to complete at one hundred and twenty three.

Stephanie Coppel: You'll also note that this total measures completed up here, and has gone from three to four.

Stephanie Coppel: It moves and responds as you make changes.

Stephanie Coppel: One other major thing to note is that if teams have more than one person in the system at the same time that

Stephanie Coppel: um the team, we ask that the teams coordinate with each other to make sure only one person is working on a specific measure. At the same time you can have more than one person in the system at a time filling out different measures. Um, But

Stephanie Coppel: there may be issues if two people are working in the exact same measure at the scenes at the same time. So please Ah, be sure that you're coordinating

Stephanie Coppel: um.

Stephanie Coppel: So you'll see that the submit or set button is brayed out here because we Haven't completed the total measures for this core set.

Stephanie Coppel: I'm going to go back and navigate to those adult measures that showed complete earlier when we first logged in

Stephanie Coppel: um, and you'll see the total total measures completed are all thirty, two. If you scroll down you can see they're all completed.

Stephanie Coppel: Um! And you might be wondering Why is this submit corset button still right out? Um. The system will not allow you to submit the entire core set until all the measures are completed and the qualifier questions,

Stephanie Coppel: the qualifier questions have been slightly rebranded from the previous application. You may know them as admin questions.

Stephanie Coppel: You can see the status of those admin questions underneath the link. So you can see this is incomplete.

Stephanie Coppel: Um, and that we must complete the qualifier questions before we submit the core set. So I navigate in here. Um. This is in a very similar way to the measures themselves. You'll see your blue bar orienting you your save your print, um,

Stephanie Coppel: and you can go through and fill this out. We have the same validate down here. Um! And you can see there's an error. I'm just going to complete

Stephanie Coppel: these qualifier questions. It's going to give me that same warning that you have errors you still want to complete. I'm going to say yes.

Stephanie Coppel: Um. So now that we've completed those you can see the status has changed. You have this nice little green circle with the check mark um, and this submit corset button is no longer grayed out, and we can submit it. So i'm going to go ahead and submit that

Stephanie Coppel: we get that pop up. The core set is submitted successfully. Yay big celebrations. This is exciting. Um! And when we go back to the home screen you can see that the status of the adult core set is submitted.

Stephanie Coppel: While we are on the home screen. I do want to demonstrate that you can click on these little three dots and click export, so this will allow you to export all the measures in a given for set. Um! We already went over how to do it for an individual measure. Um! But if you're trying to export all the measures in a four set.

Stephanie Coppel: You can do it from that little drop down on the home screen, and it will take you to this screen. These buttons here will let you navigate

Stephanie Coppel: down to a certain

Stephanie Coppel: measure if you want um. But once you're on this screen, you can put this orange print pdf button. It'll take a second to prepare, because it is very long, as you can imagine. Um! But what's really fun is that this Pdf:

Stephanie Coppel: We'll also allow you to click through and navigate to any specific measure, and you can see

Stephanie Coppel: um.

Stephanie Coppel: These are all blank because we haven't filled them out, but you can see that it's

sixty seven pages of

Stephanie Coppel: measures.

Stephanie Coppel: Ah! So we can now go back to the home screen. Ah, one other thing that I didn't touch on. Is that the bottom of every screen and within the measure screens themselves. Also. On the top are the email addresses for the different

Stephanie Coppel: support options. So the Mdct Health Email address will be for site issues for access for errors. Um, navigation issues, questions about how to do something in the site.

Stephanie Coppel: Um,

Stephanie Coppel: And then the Mac quality. Ta

Stephanie Coppel: email address is for ah policy and content related questions. Um. And if you do accidentally send your question to the wrong email address. Um they will forward it on to the right one. So don't worry about that

Stephanie Coppel: couple last-minute things I want to make sure that I touched on before we start going through. The questions entered.

Stephanie Coppel: I want to say again that the measures will remain editable even after you mark them complete. We hope that you

Stephanie Coppel: you are cautious about hitting complete for a measure, as we'll be checking that in our review to know when we can start looking at measures.

Stephanie Coppel: Um, but just wanted to streamline the process of making updates as needed, because the data that's entered into this system by you all is the data that will be used to create the score card and the data that will be used for those quality measures for your State.

Stephanie Coppel: So if a change needs to be made, the States have to go in and make that, and we wanted to make that easy for you all.

Stephanie Coppel: Um, the help desk team as well as the um technical assistance team can actually log in and see what you're seeing in real time. So if you're having an issue um, the technical assistance team can go in and see how you filled it out, and maybe say, hey, I think

Stephanie Coppel: it should look like this instead. Um! So just know that when you're asking questions, if you want to say, hey? I thought about this measure, and i'm not sure if this is the correct way. Could you take a look? The technical assistance team has the ability to go in and do that

Stephanie Coppel: um

Stephanie Coppel: to answer some questions that we've received in the past. Um, This site will hold the data from Fy twenty-one forward everything

Stephanie Coppel: before that is still available in the old Macro system. And you can log in there

Stephanie Coppel: if you need access to that old data, but it will not be available in this new system. But as we continue to add reporting years in the new site, you'll always be able to go through and check those there.

Stephanie Coppel: Um!

Stephanie Coppel: I think that I've covered everything on my end, so i'm going to go ahead and stop

sharing for now, and we can start going through

Stephanie Coppel: the questions. My colleague David, is going to help me out and read some aloud.

David Koger: Thanks, Stephen. Um. Okay. So we'll kind of start off the top here since. Why, two thousand and twenty reporting was delayed. What is the deadline for? Cy Twenty and Cy twenty one Health home recording.

David Koger: Um, That is going to be a question for the policy team. Um for anything that is going to be reported in this site. Um! My understanding is that both

Stephanie Coppel: ah fiscal year twenty, one and twenty-two will be due by December thirty first twenty twenty-two um. But if there are more specific questions. Um, please email the Ah technical assistance email address.

David Koger: Okay. This question is from Bill. Suppose you report data from another source and the State disagrees with it, or wants to validate it.

Stephanie Coppel: That is going to be another question for the policy team on how to best enter that into the site.

Stephanie Coppel: So it makes sense to them as they're pulling the data.

David Koger: Um, here's another question. Is there an option to roll back to entries from previously? So, like two days ago or three days ago.

David Koger: There is not an option available to navigate back to previous saved versions. No,

David Koger: I know you cover this, but I just want to make sure it's clear? Somebody asked. Can you complete a measure without validating the matter?

Stephanie Coppel: But

Stephanie Coppel: yes, so actually, I will go ahead and turn my screen again, and just show you what happens, because when you click the complete

Stephanie Coppel: measure um,

Stephanie Coppel: it actually runs the validation in tandem.

David Koger: Um.

Stephanie Coppel: So if I go back into,

Stephanie Coppel: and I go into a brand new measure that I haven't built anything out for um. If I go down and click complete measure, you'll see that it does the validation at the same time. Um! So all these validation errors pop up, and it is alerting me that I have them before I would complete.

Stephanie Coppel: I can click, Yes, and it'll show us complete.

Stephanie Coppel: But we suggest that you use the validate button to manually validate first before

Stephanie Coppel: clicking complete and marking it as complete.

David Koger: Um, I think this one might be another one to send to the Ah help's email, but i'll ask So when completing the child report when it asks if I'm reporting on an adult measure, Do I choose population not covered or other

Stephanie Coppel: that's going to be a question for the policy team. Yes,

David Koger: is the export available only in Pdf. Or is a Csv. Also an option.

Stephanie Coppel: Currently, our only option for export is Pdf: Yes,

David Koger: Um. Our roles still associated. For example, State director, State editor, et cetera. Will the State directors still need to certify the results prior to submission to Cms.

David Koger: That's a really good question. And no, we've gotten rid of the different types of State roles. Um! That was some feedback that we received from State users. Ah, before building this new site that a lot of these roles didn't um

Stephanie Coppel: correlate to actual state roles in a way that made sense. Um. And so we made this system as flexible as possible to accommodate whatever way the State has their approval process set up. Um. So any user can go in and

Stephanie Coppel: to complete or submit a corset, and we recommend that the States kind of formulate their own process that works for them to walk through like approvals. And who's going to submit, and things like that.

David Koger: Um! Are we receiving new usernames and passwords for this? Or do we use the same username and password we previously used for macro

David Koger: so in that pro um. Towards the end of the last macro-reporting period the site moved to I dm

Stephanie Coppel: uh so if you had an id and login, username and password uh, you can use that same username and password, but you will have to request a new role, as this is a new site. Um. And if you need assistance with that you can email the Mbct. Help um email. Address

David Koger: this one from call Kirby. Hi, what you just said about going in order referring to entry within one measure only. Right? I. E. Is it okay to do measures out of order within the measure list? Since validation is at the measured level.

Stephanie Coppel: Great question. Um, yes, the validation is at the measure level. You can complete the measures in whatever order you want, but within a singular measure. You want to fill it out from top to bottom in order

David Koger: Uh, will the data within this new system be accessible for analytics by States.

Stephanie Coppel: That is a great question, and I think a better question for policy

Stephanie Coppel: to answer how they will be using and making that data available.

Okay,

David Koger: is it possible to submit stratifications, race, geography, et cetera, as a file, instead of entering them manually.

Stephanie Coppel: Not in this iteration of the application, all the data has to be entered manually um through the system. But that is something we are looking into for future versions of this site.

David Koger: Why, Medicaid and Chip are separate reporting for the child. Corset measures. Are we allowed to submit the combined rates?

David Koger: Yes, so each State manages their um medicaid and Chip

Stephanie Coppel: in their own way. Um, and each State gets to determine how they want to submit their data to Cms. Um. If a State has questions about whether they should be submitting separately or combined for the Medicaid and chip child process. Ah, you can email the policy

David Koger: all right. And then this one from Jamie. Can you go over how to make a change to a measure after it is marked as completed.

David Koger: Yeah, absolutely

Stephanie Coppel: all right. So we are back in that child corset

Stephanie Coppel: you saw just now we were in a Mr. Ch. And we marked it as complete. Um, if I go in, this is the one that I didn't

Stephanie Coppel: answer any single question and hit complete, so I can go in and click,

Stephanie Coppel: and it operates just the same

Stephanie Coppel: as if I did not click complete.

Stephanie Coppel: Um. I can save it again.

Stephanie Coppel: And actually, if it was more complete, and I go in and make changes and navigate back, You can see the status actually does change to in progress. Um! So it was complete. We navigated in, made some changes, and it goes back to in progress. We can go back in

Stephanie Coppel: click, complete measure,

Stephanie Coppel: and then it'll change back to complete

David Koger: this one from Aiden. If different people are submitting data from the same state, can they see each other's data?

David Koger: Yes, another great question.

Stephanie Coppel: Um, Again, Our Our big message here is we do not want State users from the same state working in the same measure. Um. But if I am working in, let's say the child Corset, and my colleague is working in the adult porset.

Stephanie Coppel: I can navigate over to the adult core set and see what my colleague has entered. It is all available. It's like one instance for an entire state. So again, as long as two people are not working in the same measure

Stephanie Coppel: that um

Stephanie Coppel: all the data will save appropriately and be available to anyone who logs in from that state only no State is able to see the data enter for another state. Besides that,

David Koger: then gift

David Koger: this one from Connie. Uh, will we still get email notifications. Once measures are submitted to Cms.

David Koger: You will not receive notifications once the measures are submitted to Cms. Once you submit,

Stephanie Coppel: or once you click, complete on a measure, or submit your core set. If any changes are required, you will hear from the Cms. Team

David Koger: this one from John. Will we be able to view archived reports submitted in Macro from this interface.

Stephanie Coppel: No anything submitted in the old Macro system. It's still available in the old Macro system. Um, if you want to log in there and view your data that way. Um. But the data entered in the old macro system will not be available in the new. M. Dct. Qmr

Stephanie Coppel: interface

David Koger: question regarding reporting dates. So from Jim he's just confirming the reporting date ranges for um fy, two thousand and twenty-one are one, one, two thousand and twenty to one thousand two hundred and thirty, one, two thousand and twenty, and then for Ffy, two thousand and twenty-two It's Uh

David Koger: January first, two thousand and twenty one to December the thirty, first two thousand and twenty one

Stephanie Coppel: uh I'm going to have to defer to the policy team on that. Um. So if that individual wants to email the

David Koger: can. The date ranges for each measure be auto-populated to the expected date ranges to reduce data entry.

Stephanie Coppel: That is definitely something that we are considering in a future release.

Stephanie Coppel: Um, right now that is not implemented um and won't be implemented in this reporting period, but definitely something we're considering for future iterations.

David Koger: So I found

David Koger: Harvard in case the system is down. Do we have a backup plan in place?

Stephanie Coppel: Ah, we do have contingencies from the technical perspective that the site should not be down for an extended period of time. Um! If that does happen, we will reach out to users with further instruction,

David Koger: and this one from Zamda Sam. I have access to the Mdcc site, but cannot see the links to report corset data. When will the recording become available.

Stephanie Coppel: Um, That is curious if that user is just seeing the homepage, because at minimum

Stephanie Coppel: the user should see the adult corset already populated with the options to add a child corset and potentially help home dependent on their state requirements for that year. So if that's happening, please email the Mdct. Help desk

Stephanie Coppel: um and include a screenshot, if possible, to show us what you're encountering, and we'll work through that with you.
