

**2023 State Timelines for Initiating Unwinding-Related Renewals
As of June 29, 2023**

This chart outlines state Medicaid and CHIP renewal timelines and distribution plans, including for individuals that states have preliminarily identified as likely ineligible for Medicaid and CHIP. During unwinding, some states are prioritizing renewals for individuals identified as likely ineligible for Medicaid based on findings of income ineligibility at a renewal conducted during the COVID-19 pandemic. Some states also prioritized renewals using other criteria that indicated potential ineligibility for Medicaid and CHIP, including categorical ineligibility (e.g., aging out of a group) and beneficiaries’ failure to provide requested information to complete redeterminations during the continuous enrollment condition. States may be prioritizing renewals for individuals who meet some or all these criteria during their unwinding period and plan to distribute these cases over a varied length of time.

1. This is generally the anticipated effective date for terminations for the first full cohort of unwinding-related renewals. In most states, this occurs at the beginning of the month and aligns with the first date for terminations for procedural reasons (e.g., not returning a renewal form). In states holding certain procedural terminations due to a CMS-approved mitigation strategy or other reason, the dates in this column represent terminations for the first cohort of renewals, not including those due to a

procedural reason. Terminations for individuals the state has redetermined as ineligible for Medicaid and CHIP may occur on or after April 1, 2023.

2. This column captures if states are prioritizing any members who are likely ineligible during any particular months of their unwinding period. Some states are prioritizing individuals identified as more likely to be ineligible for Medicaid (by no longer meeting income or categorical requirements) based on a redetermination of eligibility conducted during the Families First Coronavirus Response Act (FFCRA) continuous enrollment condition. In some states, this also includes beneficiaries who did not respond to requests for information to renew eligibility but remained eligible and enrolled in Medicaid due to the continuous enrollment condition.

3. Alaska will initiate renewals over an 18-month period in light of unique and severe environmental and operational challenges in the state, including the inability to ensure beneficiaries receive mail on a timely basis. The additional time is necessary to protect applicants and beneficiaries and prevent inappropriate losses of coverage and is subject to additional conditions agreed upon by CMS and the state.

4. Tennessee conducts mid-month terminations and begins and ends coverage effective any day within a given month. The first cohort of renewals were completed effective mid-June.

5. In Utah, renewals for individuals with known eligibility issues and cases where no review was completed during the continuous enrollment condition will be prioritized to occur earlier in the unwinding period and continue throughout the 12-month unwinding period. Prioritization is a sliding scale and based on the length of time the case has been kept open and utilization of Medicaid services.
