RE: October – December 2021 Phased-Down State Contribution Final Per-Capita Rates

October 15, 2021

State Medicaid Director:

The Medicare Prescription Drug, Improvement, and Modernization Act of 2003 (MMA) requires that the Centers for Medicare & Medicaid Services (CMS) notify each State of its Medicare Part D clawback adjusted per-capita drug payment expenditure rate when there is a change in the quarterly rate. Payments for the phased-down State contribution are made on a monthly basis. These payments are defined by the MMA to be the product of the annual per capita full dual-eligible drug payment amount and the monthly State enrollment of full-benefit dually eligible beneficiaries.

Additionally, on March 18, 2020, the Families First Coronavirus Act (P. L. 116-127) was signed into law. Section 6008 of the Act provided for qualifying states a temporary increase to the FMAP. This increase is effective retroactive to January 1, 2020. This increase in the FMAP also affects the calculation of the phased-down State contribution per capita rates starting January 1, 2020. This adjustment will only apply to states that qualify for the temporary FMAP increase and while the temporary FMAP increase is in effect. The enhanced FMAP is available for qualifying states until the end of the calendar quarter in which the public health emergency expires. Attachment 1 also provides the rates including this FMAP increase.

This letter is to notify you of the phased-down State contribution full dual-eligible per capita Medicaid drug payment amount for October - December 2021, as required by the MMA.

The October – December 2021 phased-down State contribution per capita rates are shown in Attachment 1. The per capita drug expenditure amounts for October – December 2021 are based on the values for January – September 2021, adjusted for the change in FMAP, if any, between FY 2021 and FY 2022.
